#### **From Our President**

The following, to the best of my recollection, are my remarks at Congregation Solel's 59<sup>th</sup> Annual Meeting on Friday May 13, 2016. As someone who prefers to speak from notes, rather than writing out a speech, I am trying to reconstruct an inspiring and informative speech (according to my mother, who has attended dozens of Solel annual meetings).

Last year I spoke optimistically about our brilliant clergy, top-notch staff, fiscal strength and responsibility, and committed community of congregants who have chosen Solel as their spiritual home, in a neighborhood with lots of synagogue choices. That was all true and correct, though like almost all Solel presidencies, this term has had its major surprise. More about that later.

As I was settling in as Solel president, I had the pleasure of attending the URJ Biennial Convention in Orlando in November, along with Cantor Glikin and URJ leader and Solel past-president Wendy Rhodes. At the Biennial there were many workshops for synagogue presidents, and I quickly realized how fortunate we are at Solel and how I should keep quiet.

When paired with another synagogue president for a sharing exercise, we were asked how we know when program is a success. My partner said, when there are only two or three complaints. I said, when the participants want to do it again and spend more time with their fellow congregants, which is generally how it works at Solel.

There were discussions of finances – and we were one of the prudent and fortunate URJ congregations that does not have any debt. And there were discussions about clergy – and again, we were among the most fortunate congregations with our brilliant and engaging Rabbi and Cantor. It started to get embarrassing, so I started to smile more and talk less.

Synagogue presidents joke about the number of complaints they field, and again Solel is unlike other congregations. My favorite recent complaint is that the Rabbi's Saturday morning Torah Study class is too crowded. That is an outstanding complaint! Unfortunately the solutions are elusive, with the desire to have tables for participants to set down their books, and refreshments which keeps the class out of the sanctuary and chapel. If you have any ideas, please let me know...

There was a genuine complaint about the sound system, and though it is new and was carefully designed and generously funded, there is fine tuning that needs to be done. A Sound System Task Force was formed, with Lar-

ry Mason who championed the renovation of the sanctuary, Ed Bederman who chairs the House Committee and treats Solel's facilities with the love and care of one's own home, and Jason Meltzer, who is the non-choir member on the team, but turns out to have a Ph.D. in Music Education Technology! They are working on a plan that should be in place well before the 5777 High Holidays.

We also formed a Solar Energy Task Force, after being approached by a third-party solar energy provider to install a system on our roof. Board member Art Kessler researched that proposal and helped us determine that the arrangement would not be in our best interest. After that, Art, Donnie Dann, and Amy Francetic agreed to further explore our options. Due to some reductions in available incentives, we may not have a viable path to a solar energy installation right now, but we are keeping our options open.


There were many successes this past year. Our congregants were incredibly supportive with their dues commitments. After several years of about 40 members pledging above the stated dues amount, that number jumped to over 70 for 2015-16. We hope to build on that base of generosity with additional support for our endowment, too, which also enables us to maintain our responsible budget and meet the needs of our congregant community.

In the coming year we are going to focus on legacy giving planning and reaching out to younger members who have not yet been asked to make these sorts of pledges to Solel. I noted that the men and women who founded Solel fifty-nine years ago were younger than many of us – and now it is our turn to ensure the congregation's next sixty (or more) years.

Our new Director of Congregational Learning, Ashley Plotnick is a fantastic addition to Solel. We already had a very good Religious School and with Ashley's leadership and Michael Schneider's support, it keeps getting better. Each month the school highlights a single value, with the students learning about it, and Ashley writing a beautiful, thoughtful piece for the Religious School emails. The soul of our Religious School could not be in better hands.

Through the generous support of a Solel family, we relaunched Youth Group programming to great success. Michael Schneider leads a growing group of high school leaders and middle and lower school participants. And this coming year that family along with another will again financially support our efforts.

### Reflections by Philip Orem on the Original Music Score Composed for the Shabbat service on Friday, May 13, 2016

Those of you who know me well, know that for me, public speaking is on the same list as root canals and colonoscopies, so I thought I'd share a few thoughts with you this way. Tonight's musical service is something of a miracle, certainly not of the magnitude of Moses parting the Sea of Reeds or Elijah bringing down fire from heaven, but a miracle nonetheless. I have written a good many pieces of music and it never fails that when I revisit them after a period of time, especially the better ones, that I am amazed at how they seem to have taken on a life of their own. While I certainly wrote every note, I cannot tell you where the ideas came from. This is true of tonight's service as well. A small miracle. There is also the miracle of collaboration.

One of my first memories of Vicky is that after finding out that I composed, she suggested we write a complete service. Now as you all know, she immediately got busy with the business of being your cantor and raising her young family and the time for such things became scarce. I'm certain I forgot her suggestion before getting to the parking lot. But this past fall she forwarded to me a notice from Transcontinental Publishing announcing the upcoming publication of music for Shabbat services with the short note "You should submit something." I didn't have any solo pieces, but I thought, "why not?" The Candle Blessing is short, as is the Oseh Shalom. I quickly set both of these and sent them off to Vicky.

Now my knowledge of Hebrew would not fill a thimble. Without Vicky's invaluable help with text setting and meaning of the Hebrew as well as her expertise with Reform liturgy and tradition, I could never have gotten started, much less completed this service. And let me point out there are 19 pieces of music in this service! Every time I thought I had enough there was the suggestion from my collaborator, "Well, you could add this...." And of course there is that most indispensable of collaborations in music, performers! Without you, none of this exists.

There is another miracle I'd like to point out. Vicky and her family are recent immigrants to this country. I come from close to 200 years of Kentucky farmers, the previous four generations Southern Baptists. Vicky comes from generations of Ukrainian Jews. I was half way through my sophomore year at Northwestern when Vicky was born in the former Soviet Union. And to remind you, it was the year the USSR invaded Af-

ghanistan, President Carter would call on US athletes to boycott the Moscow Olympics the next year, the cold war was warming, the next president would call the Soviet Union an "evil empire." What are the chances that these two people ever meet? What are the chances they find common ground & collaborate? Isn't that a miracle?

On the index page of the score for tonight's service I have acknowledged Cantor Vicky Glikin's invaluable contributions. The front piece reads "Ashira, a Musical Service for Cantor and Choir" and the dedication "for Vicky Glikin". You might question why it doesn't say "Cantor Vicky Glikin". She has earned that title, our collaboration is a product of her cantorate, she has been your cantor these past 4 years. But she has not been my cantor. Truth be told, if she wasn't here I would tell you I think of her more as the chick singer I have had a steady Friday night gig with....but as she is here I won't say that. I have never been one much for titles, but I can think of no greater honor than to name someone "friend." And she has been that, my friend. And that is a very great miracle for which I am eternally grateful.


